#### FEES AND RATES BYLAW - CAMPGROUNDS - BYLAW #004-2022



## THE MUNICIPAL OF THE VILLAGE OF HALKIRK, ALBERTA

Being a bylaw of the Village of Halkirk, in the Province of Alberta to establish rules, regulations and fees for the operation of all Halkirk Campgrounds.

WHEREAS Council of the Village of Halkirk, in the Province of Alberta, under the authority of the Municipal Government Act, being Chapter M-26 of the statutes of Alberta and amendments thereto may pass by-laws for the purpose of regulating and operating a municipal campground within the Village of Halkirk.

AND WHEREAS, the Council of the Village of Halkirk deems it necessary to establish fees and rates for services for the campgrounds;

NOW THEREFORE, the Municipal Council of the Village of Halkirk duly assembled enacts as follows:

1. Bylaw Title

1.1. This Bylaw may be cited as the "Fees & Rates Bylaw - Campgrounds"

- 2. Definitions
  - 2.1. "Act" means the Municipal Government Act, RSA 2000,c.M-26;
  - 2.2. "Chief Administrative Officer" means the chief administrative officer of the Village;
  - 2.3. "Mayor" meant the chief elected official of the Village;
  - 2.4. "Municipal Services" means the annual rates, fees, tolls and charges for various goods, licenses, permits and services provided by the Village:
  - 2.5. "Village" means the municipal corporation of the Village of Halkirk.
- 3. Fees & Rates
  - 3.1. Fees & Rates for municipal services for the Campgrounds shall be levied according to "Schedule A" which comprises this Bylaw.

#### 4. Severability

- 4.1. Every provision of this Bylaw is independent of all other provisions and it is the intention of the Council that if any provision of this Bylaw is declared invalid by a court of competent jurisdiction, all other provisions of this Bylaw shall remain valid and enforceable.
- 5. Effective Date

5.1. This bylaw shall come into full force and effect upon receiving third and final reading.
