A bylaw to authorize the rates of taxation to be levied against assessable property within the Village of Halkirk for the 2023 Taxation Year

Under the authority of the Municipal Government Act, the Council of the Village of Halkirk, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shows on the assessment roll of the Village of Halkirk

- 2. That the minimum amount payable per parcel as property tax for general municipal purposes shall be \$500, as per MGA Section 357.
- 3. Current taxes levied in any year shall be due and payable in full, on or before August 31st of the year in which they are imposed.
- 4. On September 1st a penalty equal to 12% of the unpaid Current Taxes, shall be added to and form part of the unpaid taxes.
- 5. On January 1st a penalty equal to 14% levied upon both Current Taxes and Tax Arrears that remain unpaid after December 31st of each year.
- 6. On May 1st a penalty equal to 15% of the total unpaid tax account shall be added to and form part of the unpaid Tax Arrears.
